#### Opacifier product for cosmetic formulations.

### **APPLICATION**

- Opacifiers are applied in a wide variety of products, usually in formulations containing anionic surfactants, the
  majority of detergent and personal care products such as shampoos, bath gels and liquid soaps.
- Due to their high effectiveness, they are used at low concentrations between 0.1-1%. It is also recommended
  to add the opacifier at the end of the formula or at an intermediate point in the mixing process, and predilute it
  in water at 10%-20% (1:5 or 1:10 ratio) to facilitate its homogenization and stability.
- It is added to transparent or translucent cosmetic products to make them more impenetrable by light and radiation. It helps the final product to look better, so sometimes a dye is also added.
